## Woof Den Policies:

\*\* Dogs must be current on vaccinations including Distemper, Rabies and Bordetella. Proof of vaccinations is required. Dogs must be in good general health, free of ticks and fleas. Heartworm preventative is highly recommended.

\*\* To be eligible for day care, dogs must be spayed/neutered if over 6 months of age.

\*\* Dogs must be on a leash when they enter and exit the facility.

\*\* Dogs can only be dropped off and picked up during scheduled times, unless prior arrangements have been made. If a customer cannot pick up their pet during scheduled hours, the dog will be boarded overnight and an overnight fee will be assessed.

\*\* **Cancellation Policy:** Customers will be charged \$25.00 if he or she fails to cancel the reservation at least 24 hours in advance.

\*\* A \$25 fee will be charged for any checks that are returned for insufficient funds.

**Client Agreement:** I, BEING AT LEAST 18 YEARS OF AGE AND OF SOUND MIND, HAVING HAD FULL OPPORTUNITY TO REVIEW THIS WOOF DEN CLIENT AGREEMENT (“AGREEMENT”), HEREBY AGREE TO BE BOUND BY THE TERMS OF THIS AGREEMENT. SPECIFICALLY, I HEREBY AGREE TO THE FOLLOWING:

1. I agree to disclose any and all medical or existing problems associated with my pet. This includes behaviors that might affect or prevent participation in group play.
2. I understand that my dog may be interacting with other dogs. I understand there is a risk of disease transmission or an injury that could result in harm or death. I understand that Woof Den, LLC shall take reasonable actions to prevent injury to my pet. HOWEVER, I WILL NOT HOLD WOOF DEN, LLC RESPONSIBLE, NOR WILL I MAKE ANY CLAIMS AGAINST WOOF DEN, LLC SHOULD ANY HARM, DEATH, OR DISEASE BEFALL MY PET DURING ITS TIME AT THE WOOF DEN.
3. I understand that if my pet gets hurt or becomes ill, Woof Den, LLC will transport my pet to Waxahachie Veterinary Clinic located at 2300 Brown St, Waxahachie, TX 75165, unless otherwise instructed. I hereby authorize Woof Den LLC, to request veterinary care for my pet, and that all charges for veterinary services will be solely my responsibility.
4. I agree that I shall be fully responsible for the full cost of any damages or harm caused by my pet to any Woof Den property, employees, or other dogs while at the Woof Den.
5. I will not hold Woof Den, LLC responsible for any personal items such as collars that are lost or damaged, while my pet is visiting.
6. I agree to pay for all fees, services and products at the time I pick up my pet after each visit to Woof Den, unless I have arranged for my credit card to be charged for recurring payments. I give Woof Den permission to charge my credit card on file for any such recurring payments. I am responsible for a \$25 fee if my credit card payment is declined.
7. I agree that I will not abandon my dog at the Woof Den. I am to provide advance notification if I need to pick up my pet at a different time than originally scheduled. I agree that if I fail to notify the Woof Den of my ability or willingness to pick up my pet, my dog (s) will be considered abandoned upon the 8<sup>th</sup> day of notification failure. I understand that if I abandon my dog(s), by default, Woof Den, LLC will become the legal owner and guardian of the animal. In its sole discretion, Woof Den, LLC will determine whether to rehome, adopt the dog, or relinquish the dog to an animal rescue of choice. I fully understand that if I abandon my dog at the Woof Den, I may be unable to retrieve my dog and will have no recourse against Woof Den, LLC.

8. I, HEREBY RELEASE, DISCHARGE AND HOLD HARMLESS WOOF DEN LLC., ITS OWNERS, AND EMPLOYEES AGAINST ANY AND ALL CLAIMS, LIABILITY AND/OR CAUSES OF ACTIONS I MAY HAVE OR THAT MAY BE MADE ON MY BEHALF OR BY MY SPOUSE, CHILDREN, HEIRS AND LEGAL REPRESENTATIVES, FOR DEATH, WRONGFUL DEATH, PERSONAL INJURY, PROPERTY DAMAGE, DAMAGE TO MY DOG(S) AND/OR BREACH OF CONTRACT OR ANY OTHER DAMAGE, ARISING OUT OF OR RELATED TO MY DOG(S) STAYING AT THE WOOF DEN, WHETHER OR NOT RESULTING FROM OR CAUSED BY NEGLIGENCE BY, OF AND/OR ON THE PART OF WOOF DEN, LLC, ITS OWNER'S OR ITS EMPLOYEES.
  
9. I SHALL DEFEND, INDEMNIFY AND HOLD HARMLESS WOOF DEN LLC., ITS OWNERS, AND EMPLOYEES FROM ANY AND ALL CLAIMS, ACTIONS, SUITS, PROCEDURES, COSTS, EXPENSES, DAMAGES AND LIABILITIES, INCLUDING REASONABLE ATTORNEY'S FEES, BROUGHT AS A RESULT OF MY DOG'S STAY AT WOOF DEN AND TO REIMBURSE THEM FOR ANY SUCH EXPENSES INCURRED.
  
10. I HAVE READ AND FULLY UNDERSTAND THE POLICIES AND CLIENT AGREEMENT SET FORTH BY WOOF DEN LLC AND HEREBY AGREE TO ABIDE BY THE POLICIES, THEIR TERMS AND CONDITIONS AND AGREE TO BE BOUND BY THE CLIENT AGREEMENT.
